In recent years, cybersecurity has evolved from an arcane technical issue into a critical risk for firms around the globe. Financial services firms face unique cybersecurity risks, given their variety of money movement systems, valuable data, and dependence on technology to serve their clients. Recent attacks that leverage SWIFT and ATMs in Japan highlight no firm or geography is immune from cyber risks. Increasingly, firms are dependent on their staff to practice sound security practices, regardless of their role, to prevent attackers from gaining a foothold on the firm’s network. We will discuss threat actors and their motivations, the responses from firms and regulators, and the role that each employee plays in defending against cyber attacks. We will also highlight the global resource shortage in cybersecurity and discuss skills that may be relevant to those looking to enter this field.



Joe Dubbs is a Director with PwC Japan's Cybersecurity practice. He moved to Japan last summer after spending more than a decade with the Financial Services Cybersecurity practice of PwC US. His background includes advising banks, insurers, and market utilities as they look to enhance and grow their cybersecurity practices. He regularly speaks to boards and external forums about the threat landscape and regulatory climate around cybersecurity.
