Nicholas Benes is the Representative Director of The Board Director Training Institute of Japan and an independent board director at ADVANTEST. Nicholas has also advised the Japanese Cabinet on FDI policy, and in 2013 proposed to the government Japan's first corporate governance code, including its reference to diversity. In 2016, he proposed changes to the Company Pension Law, leading to a study group that encouraged corporate pension funds to sign the Stewardship Code in 2017.



Mihoko Manabe, CFA is an independent board member of Torii Pharmaceutical Co., Ltd. Formerly she was also on the board of Moody's Japan as well as the Association for Women in Finance (AWF). She built a distinguished career in credit at Moody's in New York, before coming to Tokyo in 2017 to head Moody's Tokyo Corporate Finance Group.
